## Dear AC literary giants,

When you have a 1, you must have at least a 2. The outline will be worth 10 points, and the essay will be worth 30 points. The essay must be typed and should be emailed to me.

Then you return to the anthology for 3 more stories and questions. Refer to the chart.

## Planning a Persuasive Essay

The ability to write a convincing, well-planned essay is not just a school exercise. Being able to present an argument clearly in writing will help you in the work world, and in a more general way, will help you to participate more fully as a member of a free society. The ability to create an organized persuasive essay is also a staple of college admissions applications and standardized tests of all kinds. It's something you should know how to do.

The key to successful writing of this kind is to spend time planning the basic structure of your argument in advance—even if that means overcoming a natural inclination to "start writing" that many of us have. Planning saves time in the long run and adds coherence and unity to the writing. Here is a basic guide to use for practice, especially in timed writings.

## Title (six words or fewer)

- 1. Introduction—should contain the following:
- Attention-grabber. Examples include rhetorical questions, statistics, general statements, anecdotes, or definitions.
- A clearly stated thesis, expressed as a complete sentence
- · A preview of major points
- A definition of terminology and/or background information
- 2. First Body Paragraph—first major point
- Supporting evidence 1—proof of major point
- Supporting evidence 2—proof of major point
- Supporting evidence 3—proof of major point

In each case, supporting evidence should be a fact—e.g., a specific example, a research result, or a quote from a trust-worthy authority.

- 3. Second Body Paragraph—second major point (Follow the same pattern.)
- 4. Third Body Paragraph—third major point (Follow the same pattern.)
- 5. Conclusion—should:
- Restate thesis.
- Sum up and rephrase major points.
- End with a "clincher sentence," a memorable way of remaking your most important point, which will help the reader to remember the paper.
